**Advisory**

1. **General:** All training meetings will be held at the Training Center of the Full Time Training in Malabon (FTTMa), Malabon City, Philippines
2. **Training:** The training will cover the same subject as the July Semiannual Training and will be conducted in English.
3. **Schedule:** Training Meetings will be from July 24- 27, 2024; followed by a blending trip from July 28- 29, 2024. All trainees should arrive a day before the start of the training, on July 23rd. The recommended departure date is July 30, 2024
4. **Lodging:** Hospitality will be provided from July 23rd through July 29th, and meals will be provided from dinner on July 23rd to lunch on July 30th.
5. **Transportation:** Airport pickup service will ONLY be available on July 23rd at Ninoy Aquino International Airport. Please book your flight and make arrangements accordingly.
6. **Registration:** All training participants should complete their registration by April 30, 2024, according to the following guidelines:
  - a. All participants should be registered corporately by region or country (a quota has been assigned to each region or country due to the FTTM's limited capacity). Individual applications will not be accepted.
  - b. All participants must attend both the training meetings and the blending trip. Incomplete applications will not be accepted.

  - d. Each registrant from overseas is required to submit a non-refundable fee of \$300 (USD) to cover the cost of hospitality during the training and expenses for the blending trip. Payment should be remitted to the following bank account:

- f. The attendance will be divided into five groups for church visitation and sightseeing. The groups are as follows:

Group A: Northern Luzon Tour

Group B: Central Luzon Tour

Group C: Metro Manila Tour

Group D: Southern Luzon Tour

Group E: Visayas Tour (Cebu)

Please note that those who choose to join Group E should prepare for additional expenses. The recommended flight date for personal bookings from Manila to Cebu is July 28, with a departure time no later than 6:00 AM. It is also recommended that you return to your home country from Cebu (Mactan-Cebu International Airport).

Transportation to the airport for the return flight will be arranged by the groups on July 30, after the trip.
